MISSION STATEMENT:

As a gatekeeper of the democratic process, the Supervisor of Elections will uphold the election laws of the State of Florida and the constitution of the United States. The mission of the Supervisor of Elections is to enhance public confidence; encourage citizen participation; and increase voter awareness and education for citizens of all ages.

Equipment Upgrade: New DS 300 Voting Equipment



The Supervisor of Elections recently upgraded the county's voting equipment purchased from Election Systems & Software (ES&S). This upgrade replaces the eighteen year old models that have served the county since 2008 to provide an efficient and trustworthy voting experience for every voter.

Fifty new DS 300 machines were purchased using the Supervisor of Elections equipment replacement fund – a reserve account established upon taking office in 2005 to ensure aging voting equipment could be updated responsibly without requesting additional funding from the Board of County Commissioners. This approach demonstrates our commitment to fiscal responsibility and proactive planning.

The DS 300 tabulators will be used by our voters throughout the 2026 election cycle for ballot scanning and tabulation from Early Voting through Election Day...and for years to come!

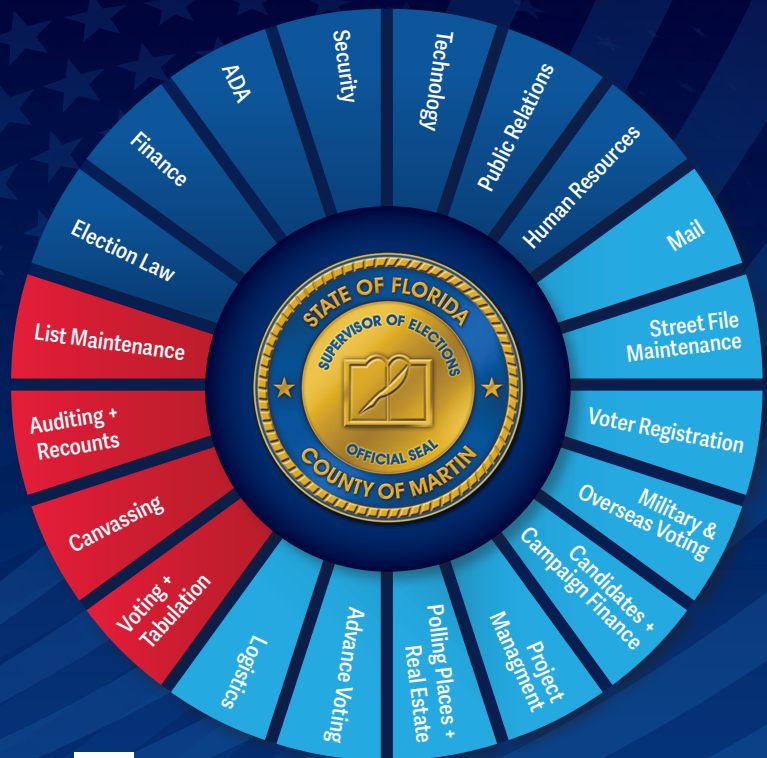

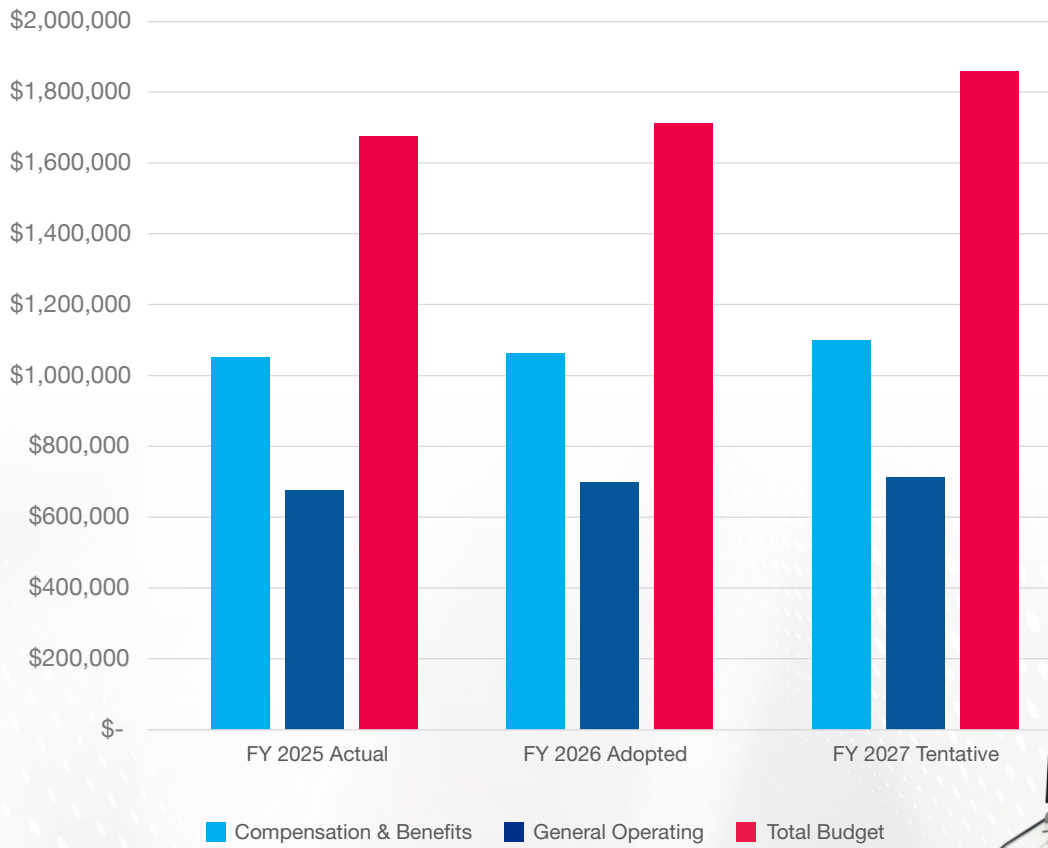

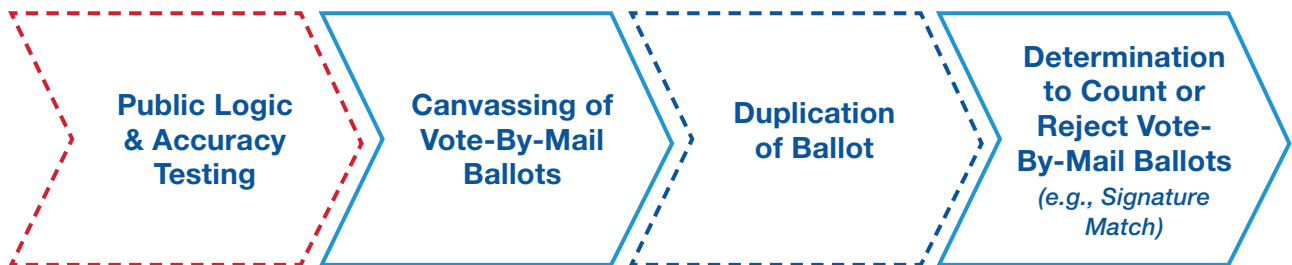

The Martin County Canvassing Board for the upcoming 2026 election cycle is composed of:

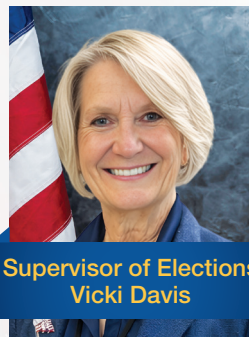

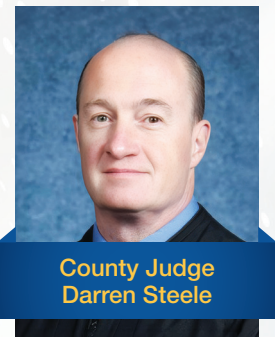

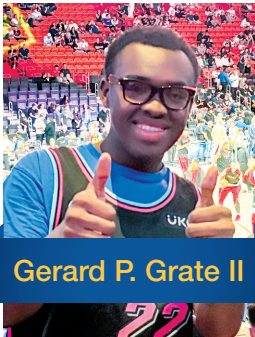

MARTIN COUNTY ELECTIONS OFFICE EXPANSION PLANS



In 2025, the Board of County Commissioners approved the expansion of the existing building at the Supervisor of Elections office.

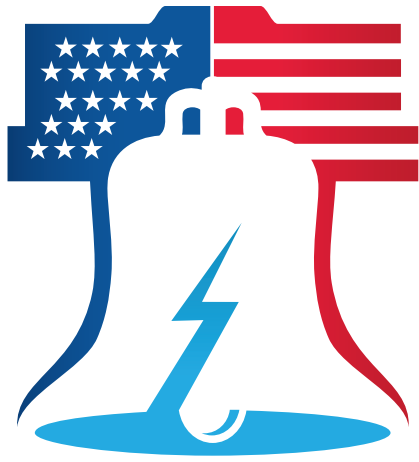
This expansion project will provide space to enhance growing operational needs and enhance the voting experience.



The building expansion will include a dedicated multi-use room for training election workers, additional meeting space, and the Canvassing Board, which will offer more transparency and a welcoming public viewing area. Construction will begin early 2027, with the new training space ready by Fall 2027, to prepare for the 2028 presidential election cycle.

The current facility layout will also change to expand early voting operations, allowing more voters to be processed quickly with shorter wait times and allowing for more voting booths for those choosing to vote early.

These improvements will strengthen the Elections Office’s ability to serve more voters while maintaining secure and efficient elections.

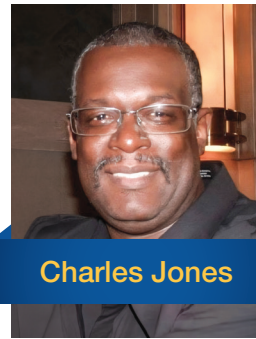

2026 NOTICE OF ELECTIONS

Florida is a Closed Primary State:

- ★ In a primary election, you are entitled to vote the official primary election ballot of the political party you are registered with and no other, FS 101.021.
- ★ You must be registered with your party of choice 29 days before a primary election, FS 97.055.
- ★ At the general election you may vote for any candidate or question on the ballot, regardless of party affiliation.
