#### Primary Election – August 18, 2026 - Martin County Canvassing Board

In accordance with F.S. 101.572 all Canvassing Board meetings are open to the public. Notice is hereby given that meetings of the Martin County Canvassing Board will convene at the office of the Supervisor of Elections, 135 SE Martin Luther King, Jr., Blvd., Stuart, Florida 34994 on the following dates:

- August 5, 2026 at 8:30 a.m. to conduct the Logic & Accuracy (L&A) Testing of Voting Equipment to be used in the August 18, 2026 Primary Election;
- August 9, 10, 14, and 15, 2026 at 9 a.m. each day to open, process, and duplicate mail ballots;
- August 18, 2026 at 2 p.m. to open, process, and duplicate mail ballots;
- August 20, 2026 at 5 p.m. to canvass provisional ballots, vote-by-mail cure ballots; and, to approve, sign and submit unofficial results to the Department of State, Division of Elections;
- August 21, 2026 at 9 a.m. to conduct county machine and/or manual recount, and to submit second set of unofficial results, if necessary. If recount is not required, Canvassing Board will sign and transmit official results and Conduct of Election Report to Division of Elections, and conduct Audit of election;
- August 22, 2026 at 9 a.m. to conduct statewide machine recount, if required and submit 2<sup>nd</sup> set of unofficial results;
- August 24, 2026 at 9:00 a.m. to conduct statewide manual recount, if required, sign and submit official results, Conduct of Elections Report and conduct Audit of election;

A candidate, a political party official, or a political committee official, or an authorized designee thereof, shall be granted reasonable access upon request to review or inspect ballot materials before canvassing or tabulation.

Any challenge of a vote-by-mail ballot must be made before the ballots are canvassed, F.S. 101.68(2)(c)4. It may become necessary for the Canvassing Board to reconvene at times other than specified above. If so, the date and time will be announced at the conclusion of the previous meeting, posted online at [www.MartinVotes.gov](http://www.MartinVotes.gov), and posted on the door of the Supervisor of Elections Office.

Section 286.0105, Florida Statutes, states if a person decides to appeal any decision by a board, agency, or commission with respect to any matter considered at a meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
